REPORTS OF COMMITTEES AND BOARD MEMBERS

RAILS. Simmons reported that Dee Brennan, the executive director of RAILS, asked for building photos from all member libraries. Duane Bonifer, the executive director of communications and marketing at Monmouth College, took high resolution photos of the exterior of the library for free.

Laura Turner, the RAILS board chair and president, would like to see more representation from non-public libraries. Currently only two (out of fifteen) board members are from non-public libraries.

UNFINISHED BUSINESS

The Kirkwood Library has received permission to mount a bookdrop on the exterior wall.

A maintenance employee from the Village of Alexis looked at the leaking sewer pipe in the Alexis Library's basement. He reported that it needs to be repaired. Good will follow up.

DIRECTOR'S REPORT

Circulation/Programs/Internet/Door Count Statistics. Adult circulation was up at the Main Library by 953. On Election Day, the library waived fines for returned items. The library is also offering Fine Free Fridays in November. One individual has checked out the Figge Art Museum pass so far. Good will continue to publicize it.

Per Capita Grant Questions. The board reviewed Chapter 8, Public Services: Reference and Reader's Advisory Services of the "Serving Our Public 3.0: Standards for Illinois Public Libraries, 2014." Good mentioned that in some cases, patrons are directed to county and city resources (for City Council minutes, for example). Links to these resources are provided on our website. President Willhardt reviewed the highlights from Chapters 6-10 of the Trustees Facts File Third Edition. These chapters were about Intellectual Freedom, Planning, Human Resources, Facilities, and Budgeting and Financial Management.

For continuing education, a trustee needs to complete an educational program that focuses on the needs of patrons with disabilities. Vancil volunteered to watch "JJ's List: Disability Awareness" on the RAILS website prior to the next board meeting. She will report on our commitment to serving patrons with challenges, disabilities or differences.

Building Updates. Jeremy Gerard of Gerard Tuck Pointing in Oneida tuck pointed part of the south wall and readjusted the gutter. Price: \$2,850. The roof will need some repair work in the spring for the seams and the flat section. Good is awaiting a bid from Holthaus Companies, Canton.

Personnel Updates. Adult Services Librarian Rebecca Eaton has submitted her resignation. Her last day is November 29. Ads have been placed on library websites. Amber Harvey is on maternity leave for the next eight weeks.
