Circulation/Programs/Internet/Door Count Statistics:

Director Good provided the Director's Report of Statistics for November. The numbers were down a bit overall from the same time period 2023, but it was reported that there was good attendance in December with approximately 545 people attending Christmas on the Square.

The next topic discussed was strategic planning for next year. Trustees took a tour of the full building. There was some dialog about a desire to have more space and to utilize the second floor, if feasible. It would be good if at least a few strategic items planned could be quickly completed to be easily noticed by patrons and staff as an encouragement. Items such as carpet and paint would be positive improvements without major expense. Another idea would be to reupholster the furniture. Director Good will provide a mini-facility enhancement plan for the next 5 years and obtain some estimates.
